6. Assessment Criteria

6.1. Exegetical Essay

Students need to demonstrate strength in reading and research, as well as in exegetical method. See separate booklet, "From Text to Ministry: A Short Guide to Writing Spiritually Rich Exegetical Papers" (available on the RTC eCampus).

Your essay will be evaluated on the following criteria:

Introduction: clear introduction grabbing the reader's attention, setting out the topic to be discussed, the approach taken (i.e., your method), and the answer to your question (5%)

Context: analysis of literary structure (with exegetical outline), literary and historical-cultural context (5%)

Exegesis: detailed engagement with the text; careful tracing of the author's flow of thought; analysis of key words, connectors, phrases, and grammar, conclusions based on passage(s) (30%)

Scholarly literature: ability to critically engage with secondary literature: identifies, conveys accurately, and critically assesses the most pertinent secondary sources relating to the tpic of the paper including commentaries, journal articles, and reference books, etc. (30%)

Clarity and quality of argument: topic and key issues clearly identified; development of a clear and coherent argument to address the topic; convincing and balanced arguments, handles complexity of issues without sweeping generalities; recognises and deals with weaknesses and counterarguments appropriately; smooth development of ideas; conclusions flow logically from arguments presented (10%)

Style: clearly structured (with appropriate headings), clarity of writing, spelling and grammar, interesting presentation, accurate referencing, footnotes, and bibliography (10%)

Implications: practical, insightful applications to personal life, church, and/or society; homiletical or bible study outline (5%)

Conclusion: clear summary that "wraps up" the essay; no new points in the conclusion but demonstrates that you accomplished what you set out to do in the essay; provides a sense of closure on the topic (5%)

6.2 Topical Essay

Students needs to demonstrate strength in reading and research, as well as in both exegetical and theological method. Your essay will be evaluated on the following criteria (in descending order of importance):

1. **Coverage of Relevant Content:** your essay should cover the essential content thoroughly, and reflect awareness of the range of key issues relevant to the subject being

- discussed. The issues most pertinent to answering the essay question must receive adequate depth of treatment.
- 2. Integration of Ideas and Development of Main Line of Argument: an essay should have a beginning, a middle and an end, and sustain a main line of argument throughout. This will require you to assimilate your reading, synthesise the key points, and develop an overall argument that addresses the question asked in a logical and persuasive manner. The essay structure should reflect the particular questions asked in the essay topic.
- 3. Critical Reflection: an essay is essentially an exercise in independent, critical thinking. The essence of critical reflection is the ability to evaluate, in a reasoned and thoughtful manner, the assumptions, perspectives and arguments of others. It entails moving beyond an immediate subjective reaction to something (e.g., "I really like what Carson said" or "Dunn is too liberal") to giving objective reasons for why a particular line of argument is to be accepted, rejected or qualified at certain points (e.g., "Carson's perspective is helpful and illuminating because...", or "Dunn's argument is open to criticism at the following points...", or "Wright's approach is stimulating and helpful, but his underlying assumptions are questionable, for the following reasons"). In short, critical reflection is a matter of having sound reasons for the position you adopt or the evaluation you offer.
- 4. Extent and Quality of Reading and Research: an essay should be based on thorough research; the sources used should, where possible, reflect a variety of perspectives on the topic under discussion. The bibliography should include at least 10-12 items. Students at levels 6 and 7 should engage scholarly works in their essay from at least two different schools of thought. Students at level 8 should engage scholars from at least three different schools of thought.
- 5. **Style and Presentation:** your essay should be clearly written, grammatically sound, and well presented. Clarity and accuracy enhance the appeal of any essay. It is essential that you follow the footnoting and bibliographical conventions prescribed in the academic handbook.
- 6. **Effective Footnoting:** in essays, subsidiary material should be printed in footnotes (or endnotes). Footnotes should be used (i) to cite the sources from which you have derived key facts, opinions or quotations; (ii) to add comments, explanations, examples, or references that are relevant to your argument but which would interrupt its flow if included in the main text; and (iii) to document the differing views of other authors on the point being made and the sources where these can be followed up.

7. Workload Guide

The following guide indicates the hours we expect this unit to require, though this will vary from student to student. If you invest this amount of time we would expect an average student to get a reasonable grade. More time may be required for very high grades or for those who read or work more slowly. Much more time will be required if you frequently check Facebook or are generally inclined to distraction or procrastination! Our guideline for study is that a full unit will equate to 36 hours in class and twice that out of class, for a total of about 110 hours.
